









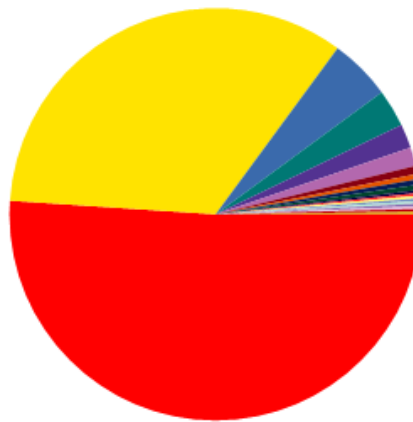

Case Count by Nature of Suit

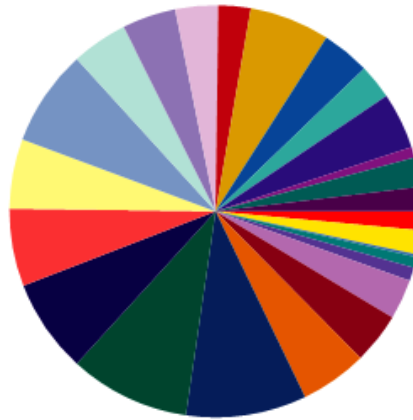

**Case Count by Capacity**

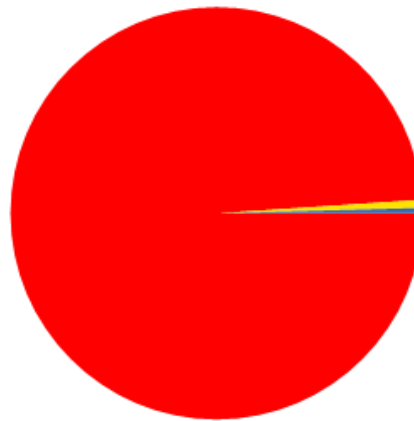

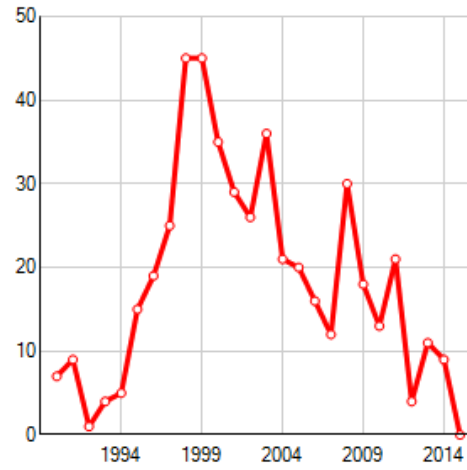

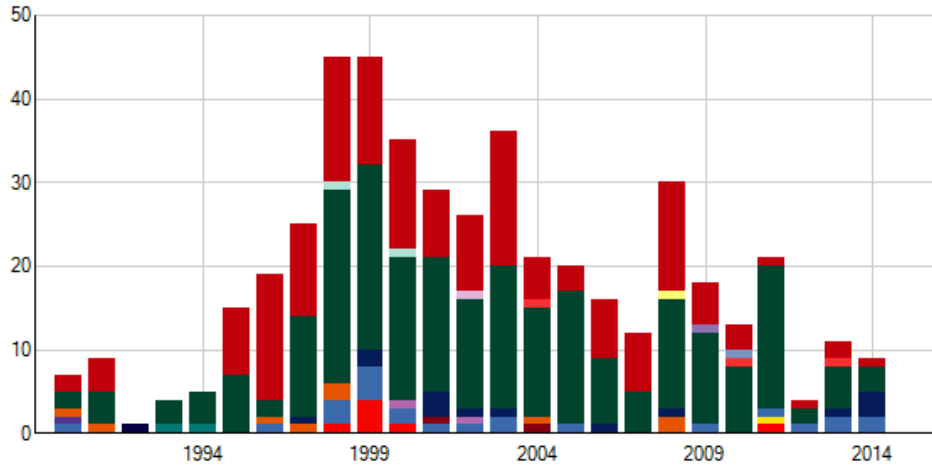

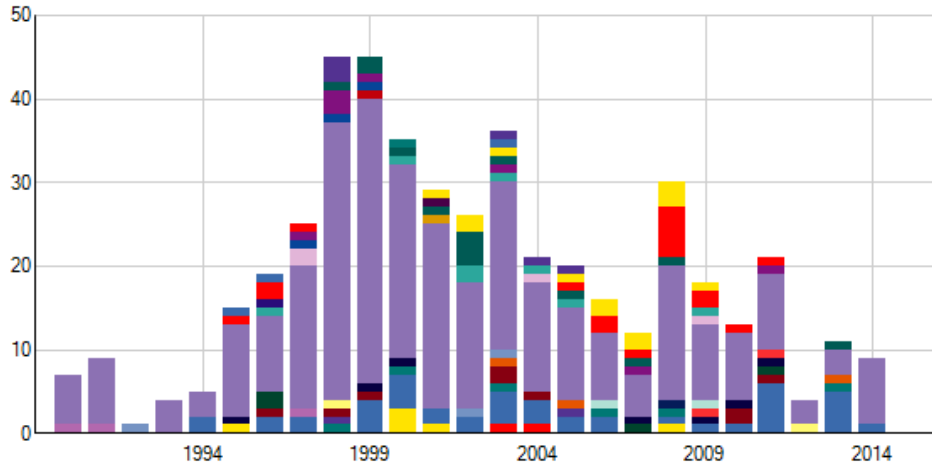
